Motion was made by J. Rummer to accept the agenda with the 2 additions and to move the Short-Term Rental Discussion to the beginning of the meeting to accommodate the visitors. Second by R. Latimer. **Passed.**

Short-Term Rental Discussion: R. Beydoun started the discussion with the statement: "We as Board members are here to serve you. You elected us and put us in office. We are here to represent you not the other way around." Creston Scheel started the discussion with a recommendation to the Board to postpone the current draft of the Short-Term Rental Ordinance in favor of putting together an exploratory committee to gather more information on complaints, to more accurately identify areas of concern before proceeding with a regulatory framework. Noemi Turner, Cindy Boswell, Jonathan DeWindt, Tim Turner, Amy Flavin, Eric Weimer, William Whitefoot, Paul Mooradian & Brooke Maki spoke to the matter. A lively discussion followed. A sign-up list for the Exploratory Committee was presented for people to join the committee.

Motion was made by R. Latimer to move the hiring of a deputy treasurer to the beginning of the agenda to facilitate her being able to leave. G. Bloomfield seconded. **Passed.**

Hiring of a Deputy Treasurer: Erin Fortune's resume was presented. R. Latimer motioned to appoint Erin Fortune to the position of Deputy Treasurer. G. Bloomfield seconded. **Passed.**

Creston Scheel asked that the remainder of the Zoning Administration section be moved to the beginning of the agenda. D. Bosma so moved. R. Latimer seconded. **Passed.**

Creston Scheel asked the Board to consider the rezoning of the southern half of parcel 11-13-27-100-002 from R-1 (Residential-1) to RR (Recreation Resort). The Planning Commission recommended this to be approved. The lawyer recommended that due to a procedural error the Planning Commission needs to rehear the case. This will be reheard in a Special Meeting of the Planning Commission of 06/12/2025 @ 6:30pm.

 - c. D. Bosma noted that a gentleman who lived outside the township asked permission for a cremation burial to be buried in the North Ayr Cemetery. Discussion was held. N. Ayr Cemetery is full and closed. G. Bloomfield motioned to follow the ordinance that only township residents be allowed to be buried within the township. D. Bosma seconded. Motion was approved with a 4:1 vote to not allow people from outside Pleasantview Township to be buried within the Township.
